Sub: Dr YSRAHCT – P&C – Registration of Beneficiaries and distribution of Co-branded Ayushman – Dr YSR Aarogyasri health cards to the eligible beneficiaries – Reg.

Kind attention is invited to the subject cited above.

Ayushman Bharat – Pradhan Mantri Jan Aarogya Yojana (AB-PMJAY) is being implemented by the State of Andhra Pradesh since January 2019 as a part of the Dr YSR Aarogyasri program. The National Health Authority (NHA) has identified 55,30,834 families comprising of 1.79 Crore members, as eligible AB-PMJAY families in the State of Andhra Pradesh. As per the directions received from the NHA, YSRAHCT as the State Health Authority (SHA) has identified these families and submitted the beneficiary data to NHA for generation of health cards.

NHA has launched a co-branded card, namely the “Aayushman – Aarogyasri card”, and has put in place a process of registration, printing, and distribution of health cards. Under this process:

- i. Registration of each beneficiary will be done through the PMJAY mobile application and involves Aadhaar based Face authentication.
- ii. The village/ward volunteer will be given a login in the mobile App for carrying out the registration process. They will carry out the registration for all the families tagged to their own as well as in-charge clusters.
- iii. AB-PMJAY – Dr YSR Aarogyasri cobranded card will be generated for the eKYC verified and authenticated beneficiary data.
- iv. The generated card data will be pushed to the identified Printer for printing of cards.


- v. The Printer will print the cards and deliver them to the ANMs/Ward health Secretaries in Village/Ward secretariats for delivering them to the beneficiaries through the Village/Ward volunteers.
- vi. The village/ward volunteer will deliver the card and get acknowledgement for delivery through eKYC process.

The entire process of printing and deliver of cards should be completed before 15th November 2022. In this regard, as a first step the registration process for all 55.34 lakh households through the volunteers should start immediately and completed before 5th October 2022. Suitable instructions may be issued to the field functionaries i.e ANMs, Ward Health Secretaries and Ward and Village volunteers for completion of the entire activity as per the timelines. Daily monitoring of the progress should be done through the District Nodal Officer for GSWS and the District Coordinator for Aarogyasri. The tutorial video has been provided for your reference and dissemination to all field functionaries.
