IMPLEMENTATION OF Dr. YSR FREE CROP INSURANCE (Dr.YSRFCI) - WEATHER BASED SCHEME DURING KHARIF, 2022 AND RABI 2022-23 - NOTIFICATION OF CROPS AND AREAS (DISTRICT WISE).

NOTIFICATION

In the reference 1st read above, Government have accorded administrative approval for implementation of Dr.Y.S.R. Free Crop Insurance - Weather Based Scheme during Kharif 2022 and Rabi 2022-23 as approved by State Level Coordination Committee on Crop Insurance (SLCCCI).

2. In the reference 2nd read above, the Special Commissioner of Agriculture, A.P., Guntur have requested the Government to issue Notification orders for implementation of Dr. YSR Free Crop Insurance - Weather Based Scheme during Kharif 2022 and Rabi 2022-23 season for all

the cultivators who are cultivating Notified crops in the notified areas, crop details captured through the e-crop and after successful completion of farmer e-kyc and social audit become eligible for coverage under this scheme. The Department of Agriculture shall be continued as Nodal Department for implementation of scheme.

3. Government after careful examination of the proposals of the Special Commissioner of Agriculture, A.P., Guntur, hereby order to implement the Dr. Y.S.R. Free Crop Insurance - Weather Based Scheme during Kharif 2022 and Rabi 2022-23 season. The list of Crops and Areas notified under Weather Based Scheme for the year 2022-23 along with operational modalities, Term sheets are annexed to this order as Annexure-I, II & III.

4. The following contents are included in the Notification.

Dr. Y.S.R. Free Crop Insurance (Dr.YSRFCI)- Weather Based Scheme (WBS)

“The claims under Dr.YSRFCI-Weather Based will be settled on the basis of weather data provided by the APSDPS/ State Govt Mandal level Rain Gauge Stations/ IMD Weather Stations for the notified crops & districts and not on the individual declaration of crop damage Annavari/ certificate / Gazette Notification declaration of drought /flood, etc., issued by the Government.”

5. The Special Commissioner of Agriculture, A.P., Guntur shall take necessary action accordingly.

3. COVERAGE OF FARMERS:

All the cultivators growing notified crops in notified areas, whose crop details captured through the e-crop (a software application for capturing crop details) and after successful completion of farmer e-kyc and social audit become eligible for coverage under this scheme.

4. COVERAGE OF RISKS:

The following major weather perils, which are deemed to cause "Adverse Weather Incidence", leading to crop loss, shall be covered according to each Crop notified.

- a) Rainfall – Deficit/ Excess/ Unseasonal Rainfall, Rainy days, Dry-spell
- b) Temperature – High Temperature (heat), Low Temperature
- c) Relative Humidity
- d) Wind Speed &
- e) A combination of the above

The Andhra Pradesh State Developmental Planning Society (APSDPS) is to provide granular Weather data at regular intervals to the Department of Agriculture and accordingly, claims against each paramcter/ peril shall be calculated.

In case of any dispute/abnormality observed in the weather data captured through Automatic Weather Stations, resulting higher claims, the yield data obtained through general CCEs will also be correlated for settlement of claims.

Crop wise Term sheets are tabulated from Statement I-A to Statement VIII-B (Kharif), Statement IX-A to Statement XII-C (Rabi). The State Government settle all the eligible claims & remit the claim amount directly to the Aadhar Linked bank account of concerned farmers.
