I invite your attention to the references cited.

It is to submit that the Government ordered to achieve 100% satisfaction in implementation of all the schemes with no exception and would cover each and every individual eligible beneficiary without any discrimination. In this connection Government issued certain guidelines in Circular Memo in the reference cited.

- A. Due to wrong seeding of Aadhar to various departments services, like electricity service connections, land, etc. in the period of previous Governments and due to other eligibility parameters, some eligible beneficiaries were validated as ineligible during six step validation. All those beneficiaries have been allowed to raise grievances in Navasakam Grievances portal.
- B. Due to bank Account failures like wrong entry of bank accounts numbers, wrong IFSC Codes, Non-Aadhar seeding to Bank Accounts, Non-active Bank Accounts.

As per the directions of Hon'ble Chief Minister, the GVWV & VSWS Department has developed a procedure to address the beneficiaries of above issues. GVWV & VSWS Department proposes to disburse the benefit for all such eligible beneficiaries in two rounds in a Calendar Year - once in June & and another in December every year. These two rounds are done besides the disbursement for the eligible beneficiaries on the date of scheme launch.

**The following eligible Jagananna Ammavodi beneficiaries of AP. Education Department are left out without receiving benefits of the Schemes as per the guidelines in the reference cited, since December 2022 and eligible applications received in Jagananna Suraksha programme held in July 2023:**
