1. Introduction:

- Jagananna Chedodu scheme aims to extend financial assistance of Rs.10,000/-to the Washermen (only rajaka sub caste under BC-A), Barbers (only nayee brahmin sub caste under BC-A) and Tailors (all castes) who are economically backward.
- The beneficiaries can utilize the amount for purchasing equipment, tools, and other essentials for growing their work establishment and source of income.
- The following are the relevant timelines for rolling out YSR Jagananna Chedodu Scheme

2. Mandatory Validations/Documents

- Applicants should be between 21 to 60 years of age. (Cut off 31.08.2023)
- Selection of Profession
- Questionnaire (Establishment Location, Establishment age, Dependency on profession)
- A selfie with the applicant along with his/her establishment (geo tag and time stamp)
- The Income Certificate must be tagged to the applicant's Aadhaar number
- The Caste Certificate must be tagged to the applicant's Aadhaar number.
- Certificate of Registration of Establishment must be tagged to the applicant's Aadhaar number.
- The profession selected and the corresponding caste in the caste certificate uploaded must match.
- Applicant's eKYC
- Field verification report by WEA/WWDS

4. Application registration procedure

4.1BoP App

- In the BOP app, in the Jagananna Chedodu module, **old applicants**' data is already loaded.
- Search by Aadhaar option is provided. In case applicant's Aadhaar is found, his/her basic details will be pre-filled.
- In case the applicant's Aadhaar is not found, then a **new application** can be registered.
- In the BOP App, the WEA/WWDS captures the
 - 1. applicant's profession
 - 2. details regarding establishment (establishment Location, establishment age, Dependency on profession)
 - 3. a selfie with the applicant along with his/her establishment (geo tag and time stamp
 - 4. biometric / OTP eKYC of applicant

4.2 NBM Portal

- Applicant data captured in the BoP app will be made available in the WEA/WWDS logins in the NBM Portal.
- Applications will be forwarded to concern WEA/WWDS in secretariats where establishments were registered.
- In the Scheme verification dashboard, each application can be selected and viewed.
- For each application, the following certificates shall be validated
 - 1. Income Certificate.
 - 2. Caste Certificate.
 - 3. Certificate of Registration of Establishment.

5. Application Workflow

Welfare and Education Assitant (WEA)/Ward Welfare & Development Secretary (WWDS)

Regstration and verification of old and new applications through **BOP app** and **NBM Portal.**

Mandal Parishad Development Officer (MPDO) / Municipal Commissioner (MC)

The application shall be verified on NBM portal and forwarded to the next level

Executive Director, BC Corporation (ED BC)

The application shall be verified on NBM portal and forwarded to next level

District Collector

Final Approval of Eligible Beneficiaries

Note: Unlike other schemes the DA/WEDPS is not involved in application registration in this scheme.

The WEA/WWDS is responsible for registration of applications and verification.

NOTE: WEA/WWDS belonging to the secretariat where the applicant's shop is present is responsible for registering and verifying the application.
