**Circular on Payment of 3 months Arrear**

**No. 2629295/NTRBPS/SERP/2024**

**Dated 21/11/2024**

Sub:-SERP – NTR Bharosa Pension Scheme – Payment of 3 months arrears - With effect from 1<sup>st</sup> November,2024 and release from 1<sup>st</sup> December,2024 – certain changes in pension disbursement – Instructions – Issued.

In the reference cited, the Government has communicated the Minutes of the Meeting approved by the Hon'ble Minister for MSME, SERP, NRI Empowerment & Relations on NTR Bharosa Pensions held on 14.11.2024. Wherein decision has been taken for payment of 3 months arrears with effect from 1st November,2024 and released from 1st December,2024 and instructed to take immediate action in this regard.

In pursuance to the above instructions, the following changes are incorporated in pension disbursement.

1. Pension arrears up to 3 months will be paid to the pensioners, who are not available during the pension disbursement period and not taken pension.
2. Arrears payment shall be made with effect from 1<sup>st</sup> November,2024 and released from 1<sup>st</sup> December,2024.
3. If any pensioner has not taken pension for any reason, it will be treated as temporary migration.
4. If any pensioner has not taken pension (temporary migration) in one month, 2<sup>nd</sup> month pension will be released along with one month arrears. If the pensioners have not taken pension in 2nd month also, 3<sup>rd</sup> month pension will be released along with two months arrears to facilitate the pensioners under NTR Bharosa Pension scheme.
5. Pensioners not taken pension continuously 3 months will be treated as permanent migration and their pension will be stopped.
6. Permanent migration pensioners can place a request for rollback through WEA / WWDS and MPDO / Municipal Commissioners up to 3 months from the date

of pension stopped.

7. The Rollback pension will be released without any arrears.

All the Pension Disbursement Functionaries in the state are directed to disburse the pension as per above changes and inform the pensioners on the provisions.

The Managing Directors of BC,SC,ST, Minority, Christian Minority, EBC, Kapu, Kamma, Kshatriya, Reddy, Vysya and Brahmin Corporations are requested to release the arrears from undisbursed pension amount returned by SERP, Vijayawada.

All the District Collectors are requested to give wide publicity on the payment of 3 months arrears and monitor the disbursement of pensions.

All the MPDOs/Municipal Commissioners in the state are requested to monitor the pension disbursement and ensure that the undisbursed pension amount should be remitted to Government soon after closing of pension disbursement for proper implementation of the above process.

All the Project Director, DRDAs in the state are requested to supervise the pension disbursement and remittance of undisbursed pension amount.
